During the event I am obligated to supervise the minor and in particular to ensure that the stipulations of the Youth Protection Act are adhered to (educational competencies in setting the minor clear limits, in particular with regard to the consumption of alcohol) As authorized custodial person I confirm herewith my age of legal majority as well as the correctness of the information given above.*

**The forging of a signature is a criminal offence in accordance with §267 of the German Penal Code. Furthermore, an attempted forgery is also liable to prosecution. An ID Card or passport is to be presented as proof of identity!**

The delegation of temporary guardianship can only be granted for the respective event. A transfer of such to landlords/event organizers is not allowed. The custodian person must be capable of guaranteeing the supervision of the minor and be present the whole time during the minor's attendance at the event.

German privacy protection.: All information provided is intended exclusively for the intended purpose and will not be saved or published. After 24 hours, the retained documents are destroyed according to GDPR standards.
